#### 2. Centre Improvement / Plans

Please refer to the minutes from April for more detailed information. Following is a summary of the progress made in the past 4 weeks.

Lights - Melville Council have replaced all the court lights to new LEDs. This is a huge step forward for the centre. Steven to write a letter of thanks to the council.

Kitchen - Kane has started to set up the store space, so that merchandise can be moved out of current office, which will allow new kitchen space to be created. Squash club have agreed to contribute appliances to the new space - Dishwasher (\$1155), Cooktop (\$484) and another wall over (\$550) - items will be purchased in the next couple of weeks. Timeframe for kitchen is 3-4 weeks.

Vents - no further action on this issue at this time

Outdoor area - no further action

Defib machine - Masters squash have agreed to have the defib machine available at the centre, when it is not being used elsewhere. Kane will arrange to have it mounted on the wall.

Junior program - this is being supported by several members volunteering their time to support the coaching and development of ther players. Numbers have been steadily growing this term, with up to 15 kids attending.

Promotion of the courts - still looking at ways to continue to get squash out into the community and attract more players.
