Minutes

1. Grants

4. Centre Improvement / Club Development Plans

Storage cupboard has been installed below the noticeboard. Just waiting for locks to be fitted. Thanks Rob!

New items for discussion

- Mens toilets and Water Cooler . MH to follow up with Kane.

Possible long term goals for the centre (note current fundraising will not fund these projects):

- Upgrade the front walls - discussed that this needs around \$20,000 per court to convert to glass front walls, we don't really have any ideas on how to raise that much money. Steven suggested that this should be our long term goal for the club / centre.

- Air conditioning

5. Membership

We finished 2020 with 136 members.

Membership fees for 2021 will remain the same. We have a few new members who have joined under our Xmas special.

Life Membership - criteria finalised, and has been distributed to members via email.

Possible options to increase membership:

- Juniors - all juniors who are part of the Monday program will be encouraged to become members of the club.
- Flyers to Murdoch Uni - discussed whether this could be a useful place to advertise squash, felt it was worth a shot. We will contact the university and see what options there are to advertise squash internally.
- Recontact the schools targeted last year to promote junior programme, flyer to promote what is happening at the club,
- Capture names and contact details of regular casuals and contact them about the benefits of membership etc - maybe offer some 'learn how to play squash' sessions to try and encourage adults to improve their squash
- Past players - actively follow up members who don't renew their membership, or past players, and encourage them to rejoin the club

6. Juniors

Will commence again in Term 1 2021. Runs from 4.00pm to 4.45pm (coaching), then through to 5.30pm for games, but may extend to 6.00pm if numbers increase again. Current numbers are around 30-40.

Funding allocated to Junior Program for equipment etc, estimated that we need to allocate \$1500 per year. This is currently being funded by \$500 from Kidsport, and all funds raised from the Containers for Change, around \$40 per month. Initial costs will be buying appropriate balls for each court for coaching.

Junior Open Day - may run an open day again towards the end of January to encourage any new juniors.

If you know of any juniors who may be interested please point them in this direction.

7. Sponsorship / Shirts

Shirts - we have placed an order for a further 20 shirts, 16 of which have been purchased, the remaining 4 as stock.
