This has been put on hold in recent months as it would need to tie into any new logo, and we need to ensure that we have enough support to progress this. We are looking for 3 sponsors who are willing to contribute \$400-500 each to have their names on the shirts, with the aim to make shirts affordable for all members to purchase, but in particular, our pennant teams.

As at October we have two sponsors signed up for the shirts, and are seeking one or two more. Aim to have a shirt run for early 2019.

## **12. Club Sponsorship of Juniors / State Team**

Hannah Slyth received \$200 sponsorship from the club to compete in the 2018 National Champs in Darwin.

Hannah finished 5th in the U13 girls, which is two places higher than her seeding - well done Hannah

Hannah was undefeated in the Teams event, which WA won over QLD (Qld have won the past 15 years!) - well done again to Hannah and the WA team.
