7. General Business

The following items were discussed in general business.

1. Stovetop - maybe needs to be checked and is inconsistent. Will be investigated, as often it is inappropriate cookware due to being an induction top
2. Dishwasher - could the club purchase an additional dishwasher. will be considered, issue is space in the kitchen.
3. Centre painting - query as to what is happening. Advised this is Mike's project and has been progression over the past couple of months, and almost completed.
4. Ventilation in mens toilet - Phil advised that he provided a report to the Tennis club on this issue. Club will follow up and see what is happening.
5. Air Conditioning - Frank is currently organising a quote, which will be included in the Play Your Way grant application currently being developed
6. Grant - Play Your Way - the club has been invited to submit a round 2 application for facilities. We are aiming to update all the showers, toilets and changerooms, plus air-conditioning as part of the grant, aimed to improve facilities for women and girls
7. Junior support - Josie spoke about the number of juniors (40) we have in our program and asked people to consider helping out if they are able, as more coaches make managing the program easier, and provides better opportunities for kids to develop.
8. Bernice Gryguc Trophy - nominations are open for this yearly award honouring members who make an outstanding contribution to the club.
