1. Opening of the Meeting

7. General Business

There was no formal general business to be discussed, but the following discussion occurred.

Plans for the future - discussed re-sanding of the floors, ultimately having a more permanent solution to the front walls, air conditioning, most of these are big ticket items that would need co-operation from the Tennis club and Melville council to even develop a plan. Solar panels were also suggested as a possible next step. Discussed that the club is currently using funds we generate to improve the facilities for members, and to attract new players / members.

Culture - it was suggested that the club develop a culture of engaging with casual players and offering 'guidance' or 'coaching' where appropriate to help improve their experience of the club, and squash in general. We do have a reputation as a welcoming club, and our social squash is quite popular because of this. This notion was supported, and also the development of club coaches to offer a more formal 'service' to anyone wanting to learn more about the game.

Tennis club - discussed that there is an opportunity to work with the tennis club president, Colin Lorimar, who has some good ideas about the development of the precinct as a sporting centre. Discussed possible crossover for coaching, and playing memberships. To be explored further.

There was general agreement that the centre improvements over the past 3-4 years have certainly been welcome, and make the place welcoming and a great place to play squash.
